Today, the club has grown into a sprawling 26,000 square-foot facility featuring a private pool, pro shop, fitness center, banquet and meeting rooms, a first-class restaurant and bar on a premier 18-hole golf course. Family access to all amenities including golf, range, dining, fitness, and swimming pool. Access includes a spouse and unmarried children under the age of twenty-two (22). This membership is open to anyone between the ages of twenty-one (21) and thirty-two (32). The Junior Executive Membership cannot vote or hold office at the club until a “Class A” Membership is obtained. At age thirty-three (33), the member will acquire a “Class A” Membership at the current initiation rate. Member will pay the difference between Class A and Junior membership initiation fee, minus a \$20.00 credit for each month they were a Junior Executive Member.

Springdale Country Club Contract

Agreement: Your dues, installments, minimums and other fees may be changed by board amendments during your 12-month contract.

Resignation: Requires member to give a 30-day written notice. If your resignation happens before your 1-year contract expires, you are required to pay the remaining months membership dues.

Guaranty of Payment: The signee guarantees the payment of all monies due to the club. Monthly billing statements will be sent out on the first of each month and are due by the 14th of that month. A \$35 late charge will be applied to any unpaid account balance.

By-laws: It is agreed that all persons using the membership are bound and shall comply with all the by-laws, rules, and regulations of the club.

Terms of Membership: It is agreed and understood that Springdale Country Club is authorized to inquire of my bank, promptness of payment, or other verifying data to review my credit rating and conduct any other check of my education, social position, general reputation, and those same attributes of members of my family.
